City utilities include municipal drinking water, sanitary sewer, and summer irrigation water for the majority of the city limits. Solid waste disposal (garbage) service is provided under franchise with Westowns Disposal. Police protection is provided under contract with the City of Wilder Police Department. The city is also served by the Caldwell Rural Fire Protection District, the Greenleaf Cemetery District, the Golden Gate Highway District, and the Canyon County Ambulance District. Natural gas service from Intermountain Gas Company is available to most of the city. Electricity is provided by Idaho Power Company. High-speed internet service is available to most of the city from CableOne (cable modem) and CenturyLink (DSL service). Wireless (radio-link) internet service may be available from multiple providers, such as Rise Broadband or Speedyquick. Satellite internet may also be available from multiple providers, such as Exede Satellite Internet or HughesNet.
